

# Getting Started with the NI PXI/PCI-1428

The NI PXI/PCI-1428 (NI 1428) is an image acquisition device that supports a diverse range of Camera Link-compatible cameras. This document describes how to install and configure the necessary hardware and software components to begin using the NI 1428.

## What You Need to Get Started

---

You need the following items to set up and use the NI 1428:

- NI 1428 image acquisition device
- Base configuration Camera Link-compatible camera
- MDR 26-pin Camera Link cable
- PCI, PXI, or Compact PCI computer running Microsoft Windows Vista/XP/2000 with at least one available slot

- NI D6804 breakout cable used for external triggering only. This cable provides BNC connectivity to the four external trigger lines on the 68-pin VHDCI connector (part number 187804-01).
- NI D6826 breakout cable used for medium configuration and external triggering. This cable breaks the VHDCI connector into a 25-pin D-SUB for triggering and an MDR 26-pin Camera Link cable for medium configuration connectivity (part number 190936-01).

## Safety Information

---



**Caution** The following paragraphs contain important safety information you *must* follow when installing and operating the device.

Do *not* operate the device in a manner not specified in the documentation. Misuse of the device may result in a hazard and may compromise the safety protection built into the device. If the device is damaged, turn it off and do *not* use it until service-trained personnel can check its safety. If necessary, return the device to National Instruments for repair.

Keep away from live circuits. Do *not* remove equipment covers or shields unless you are trained to do so. If signal wires are connected to the device, hazardous voltages can exist even when the equipment is turned off. To avoid a shock hazard, do *not* perform procedures involving cover or shield removal unless you are qualified to do so. Disconnect all field power prior to removing covers or shields.

If the device is rated for use with hazardous voltages ( $>30 V_{\text{rms}}$ ,  $42.4 V_{\text{pk}}$ , or  $60 V_{\text{dc}}$ ), it may require a safety earth-ground connection wire. Refer to the device specifications for maximum voltage ratings.

Because of the danger of introducing additional hazards, do *not* install unauthorized parts or modify the device. Use the device only with the chassis, modules, accessories, and cables specified in the installation instructions. All covers and filler panels *must* be installed while operating the device.

Do *not* operate the device in an explosive atmosphere or where flammable gases or fumes may be present. Operate the device only at or below the pollution degree stated in the specifications. Pollution consists of any foreign matter—solid, liquid, or gas—that may reduce dielectric strength or surface resistivity. The following is a description of pollution degrees.

- Pollution Degree 1—No pollution or only dry, nonconductive pollution occurs. The pollution has no effect.
- Pollution Degree 2—Normally only nonconductive pollution occurs. Occasionally, nonconductive pollution becomes conductive because of condensation.
- Pollution Degree 3—Conductive pollution or dry, nonconductive pollution occurs. Nonconductive pollution becomes conductive because of condensation.

Clean the device and accessories by brushing off light dust with a soft, nonmetallic brush. Remove other contaminants with a stiff, nonmetallic brush. The unit *must* be completely dry and free from contaminants before returning it to service.

You *must* insulate signal connections for the maximum voltage for which the device is rated. Do *not* exceed the maximum ratings for the device. Remove power from signal lines before connection to or disconnection from the device.



**Caution** National Instruments measurement products may be classified as either Measurement Category I or II. Operate products at or below the Measurement Category level specified in the hardware specifications.

**Measurement Category**<sup>1</sup>: Measurement circuits are subjected to working voltages<sup>2</sup> and transient stresses (overvoltage) from the circuit to which they are connected during measurement or test. Measurement Category establishes standardized impulse withstand voltage levels that commonly occur in electrical distribution systems. The following is a description of Measurement (Installation<sup>3</sup>) Categories:

- Measurement Category I is for measurements performed on circuits *not* directly connected to the electrical distribution system referred to as MAINS<sup>4</sup> voltage. This category is for measurements of voltages from specially protected secondary circuits. Such voltage measurements include signal levels, special equipment, limited-energy parts of equipment, circuits powered by regulated low-voltage sources, and electronics.
- Measurement Category II is for measurements performed on circuits directly connected to the electrical distribution system. This category refers to local-level electrical distribution, such as that provided by a standard wall outlet (e.g., 115 V for U.S. or 230 V for Europe). Examples of Measurement Category II are measurements performed on household appliances, portable tools, and similar products.
- Measurement Category III is for measurements performed in the building installation at the distribution level. This category refers to measurements on hard-wired equipment such as equipment in fixed installations, distribution boards, and circuit breakers. Other examples are wiring, including cables, bus-bars, junction boxes, switches, socket-outlets in the fixed installation, and stationary motors with permanent connections to fixed installations.

## Unpacking

---

The NI 1428 ships in an antistatic package to prevent electrostatic discharge from damaging device components. To avoid such damage in handling the device, take the following precautions:

1. Ground yourself using a grounding strap or by holding a grounded object, such as the computer chassis.
2. Touch the antistatic package to a metal part of the computer chassis before removing the device from the package.



**Caution** *Never* touch the exposed pins of connectors.

Remove the device from the package and inspect it for loose components or any other signs of damage. Notify National Instruments if the device appears damaged in any way. Do *not* install a damaged device in the computer.

Store the NI 1428 in the antistatic package when not in use.

<sup>1</sup> Measurement Categories as defined in electrical safety standard IEC 61010-1.

<sup>2</sup> Working voltage is the highest rms value of an AC or DC voltage that can occur across any particular insulation.

<sup>3</sup> Measurement Category is also referred to as Installation Category.

<sup>4</sup> MAINS is defined as the (hazardous live) electrical supply system to which equipment is designed to be connected for the purpose of powering the equipment. Suitably rated measuring circuits may be connected to the MAINS for measuring purposes.

## Installation

---

The following instructions are for general installation. Refer to the documentation provided by your computer manufacturer for specific instructions and warnings. Refer to the [Specifications](#) section for typical power requirements for the NI 1428.

### NI PXI-1428

1. Install the NI Vision Acquisition Software before installing the NI PXI-1428. Refer to the *NI Vision Acquisition Software Release Notes* for specific installation instructions.
2. Power off and unplug the PXI or Compact PCI chassis.



**Caution** To protect yourself and the computer from electrical hazards, the computer *must* remain unplugged until the installation is complete.

3. Choose an unused PXI or CompactPCI 5 V slot that supports bus arbitration or bus-master cards. PXI-compliant chassis must have bus arbitration for all slots.
4. Remove the filler panel for the slot you have chosen.
5. Touch a metal part of the chassis to discharge any static electricity that might be on your clothes or body. Static electricity can damage the device.
6. Insert the NI PXI-1428 in the selected 5 V slot. Use the injector/ejector handle to fully inject the device into place.
7. Secure the front panel of the NI PXI-1428 to the front panel mounting rails of the PXI or CompactPCI chassis.
8. Connect the MDR 26-pin Camera Link cable to the camera. Refer to your camera manufacturer documentation for specific instructions about how to connect the cable to your camera.
9. Connect the Camera Link cable to the Camera Link connector on the NI PXI-1428 front panel.
10. Plug in and power on the PXI or CompactPCI chassis.

The NI PXI-1428 is now installed and the camera is connected.

### NI PCI-1428

1. Install the NI Vision Acquisition Software before installing the NI PCI-1428. Refer to the *NI Vision Acquisition Software Release Notes* for specific installation instructions.
2. Power off and unplug the computer.



**Caution** To protect yourself and the computer from electrical hazards, the computer *must* remain unplugged until the installation is complete.

3. Remove the computer cover to expose the expansion slots.
4. Touch a metal part of the computer to discharge any static electricity that might be on your clothes or body. Static electricity can damage the device.
5. Choose an unused PCI slot, and remove the corresponding expansion slot cover on the back panel of the computer.
6. Remove your device from the antistatic package and gently rock the device into the slot. The connection may be tight, but do *not* force the device into place.



**Note** Check that the bracket of your device aligns with the hole in the back panel rail of the computer chassis.

7. Secure the device mounting bracket to the back panel rail of the computer.

8. Replace the computer cover.
9. Connect the MDR 26-pin Camera Link cable to the camera. Refer to your camera manufacturer documentation for specific instructions about how to connect the cable to your camera.
10. Connect the Camera Link cable to the Camera Link connector on the NI PCI-1428 front panel.
11. Plug in and power on the computer.

The NI PCI-1428 is now installed and the camera is connected.

## Configuring the NI 1428

---

After you have installed the NI 1428 and powered on the computer, the computer will recognize the device and assign resources to it. Use Measurement & Automation Explorer (MAX), the National Instruments configuration utility, to configure the NI 1428 for acquisition. Refer to the *Measurement & Automation Explorer Help for NI-IMAQ* for additional information about configuring the NI 1428.



**Note** Before configuring the device in MAX, ensure that you installed the NI-IMAQ driver software.

## Interfacing with the NI 1428

The Camera Link standard defines physical connections between image acquisition devices and Camera Link cameras, and it allows for flexibility of image format and data transfer protocols. The camera manufacturer defines image parameters, such as image resolution and the number of bits per pixel. Camera control parameters, such as frame-on-demand and exposure control signals, are also defined by the camera manufacturer.

These variable parameters are defined on a per-camera basis in a camera file (`camera_model.icd`) supplied by National Instruments. The NI-IMAQ driver software uses the information in this camera file to program the NI 1428 to acquire images from a specific camera. Without this camera file, the driver does not have the information necessary to configure the NI 1428 to recognize the image format of the particular camera you are using. Refer to MAX for information about valid camera attributes for your camera and image acquisition device.

Many camera files are installed when you install NI-IMAQ, and many more are available for download from the National Instruments Industrial Camera Advisor at [ni.com/camera](http://ni.com/camera). You can also create your own camera files using the NI Camera File Generator. This utility can be downloaded from [ni.com/vision](http://ni.com/vision). When installing new camera files, save them to the `<NI-IMAQ>\Data` directory.

Contact National Instruments technical support to request camera files not available in the Camera Advisor. Refer to the *Where to Go for Support* section for information about National Instruments technical support.

MAX provides a simple interface for associating a camera file with the NI 1428. Use the following guidelines to access the camera file in MAX:

1. Launch MAX, and expand the **Devices and Interfaces** branch of the configuration tree.
2. Expand the **NI 1428** branch.
3. Right-click **Channel 0** and select **Camera**.
4. Select your camera from the menu. If your camera is not in the menu, verify that the camera file is installed in the `NI-IMAQ\Data` directory.



**Note** If you lose communication with the camera during an acquisition for any reason, such as unplugging a cable or powering off your camera, you must restart the acquisition to allow the device to relock the incoming timing signals.
