## 3. Terms Associated with License Transfer 许可证转让相关条款

A) Transferor agrees to transfer to Transferee its copy of the software identified above in Section 2, including any and all materials, such as media, manuals, proof-of-purchase certificates, software critical bug notices (if any), upgrades, patches, and updates of software (and any copies thereof) associated with the license. Transferee shall accept the aforesaid software and materials from Transferor and Transferee agrees to comply with all the terms and conditions of the software license agreement accompanying the software. Transferee further agrees to perform any of Transferor's obligations under the applicable software license agreement that were not fulfilled by Transferor prior to the software license transfer.

B) As of the proposed transfer date or the date of NI's signature below (whichever is later), Transferor shall cease to use the licenses set forth in Section 2 and shall immediately uninstall from any laptop, computer, server, tablet, or any media the software associated with the license that will be transferred to Transferee. Transferor understands and agrees that, as of the proposed transfer date, it shall cease to enjoy any rights in or related to the software licenses transferred and that it waives any claim against NI with respect to the use of the software prior to the transfer contemplated herein.
